RESOLUTION TO VACATE A PORTION OF CANA COVE ROAD

WHEREAS the Town Board of Supervisors of the Town of Baileys Harbor does hereby find that the public interest requires the vacating and discontinuing of a portion of Cana Cove Road in the Town of Baileys Harbor, Door County, Wisconsin, in accordance with Wis. Stats. §66.1003,

NOW, THEREFORE, be it resolved that the Town Board of Supervisors of the Town of Baileys Harbor does hereby vacate and discontinue the portion of Cana Cove Road, Door County, Wisconsin, as hereinafter described:

A parcel of land located in Government Lot 1 of Section 11, Township 30 North, Range 28 East, Town of Baileys Harbor, Door County, Wisconsin, bounded and described as follows:

Commencing at the NW corner of said Government Lot 1, thence South 2579.18 feet; thence East 591.06 feet; thence S. 66°56'56" E., 228.53 feet to the point of beginning of lands to be described; thence N. 61°02'00" E., 128.76 feet to the westerly right of way of East Cana Island Road; thence S 33 °40'04" E., 50.17 feet along said westerly right of way line; thence S. 61°02'00" W., 133.03 feet; thence Southerly, Northerly, and Easterly 128.34 feet along the arc of a 30.00 foot radius curve to the right whose chord bears N. 28°58'00" W., 50.00 feet (incl.<= 246°09'15") to the point of beginning.

Said parcel contains 8,916 square feet.
